

Application for relief from customs duties to the Estonian Tax and Customs Board
in connection with importation of personal property upon transferring his normal place of residence to the Community
(submitted together with the customs declaration, supplementary document 4001)

¹ The property may be admitted free of import duties within six months before the resettlement, if you lodge appropriate security required by the customs authorities. The security shall be returned after the submission of the documents certifying the resettlement to the customs authorities.

² Relief shall not be granted for the goods purchased less than six months before the resettlement or for the goods subject to excise duty.

Motor vehicles, goods subject to prohibition or restriction shall be declared under TARIC CN codes.

Herewith I confirm that:

- the personal property arrived belongs to me, the non-consumable goods have been used by me at my former normal place of residence for a minimum of six months before the date on which it ceases to be my normal place of residence in the third country of departure;
- the personal property in question is intended for the personal use by me or by the family members living with me at my new normal place of residence;
- I fulfil the conditions giving entitlement to relief under which the personal property which has been admitted duty-free may not, until 12 months have elapsed from the date on which its entry for free circulation was accepted, be lent, given as security, hired out or transferred, whether for a consideration or free of charge, without prior notification to the customs authorities;
- I shall incur liability for the accuracy and correctness of the information and for the authenticity of the certifying documents;
- If I find that the information in the application is incomplete or incorrect, I shall notify the customs authorities to check the fulfilment of the conditions giving entitlement to relief and the necessity for amending the customs declaration.
- I shall undertake to establish my normal place of residence in Estonia at the latest/...../.....⁴

I am aware that:

- private motor vehicles that have been imported duty-free may be used by the members of my family living with me or to whom mainly I provide maintenance.
- the members of my family are my spouse or partner (registered) and our direct descendants under the age of 21 or dependants.
- I am obliged to provide any evidence of the details shown in the application, that are necessary for investigation, at the request of the customs authorities within three years from the grant of relief (for example, confirmation of the place of residence or certification of family members, lease or purchase contracts, contracts of employment, certification of children's schooling, confirmation of contracts of employment for family members).

³ If there is a separate list for the goods, a relevant reference shall be made into the first box of the goods description.

⁴ Shall be filled in, if the goods arrive before the resettlement of the person.

- the information provided by me shall be checked and if incomplete or incorrect information is found, a misdemeanour procedure shall be launched and the goods charged with import duties.
