

Accepting corrections in the declaration of postal parcels


1. If the customs have verified your postal parcel declaration and made corrections, you can review and accept the amendments in the declaration without exiting the application of postal parcel declarations:



















- 1) the status of your declaration is “Pending feedback“. Press the button “i” of the pending feedback status.

- 2) the information window opens. Press the green button “Entry into Complex“.




